K.S.A. 25-4148 (e) further states that the Commission may require any treasurer to file an amended report for any period for which the original report filed by such treasurer contains material errors or omissions.

The October 29, 2018 Receipts & Expenditures Report filed by the Pedro Rodriguez for State Representative campaign is illegible. An amended report must be filed which is readable.

- 2. According to the reports filed with the Secretary of State, the Kansas First Congressional District Democrats PAC reports making a \$100 contribution to Pedro Rodriguez on 9-17-18 and the SEIU Missouri State Council PAC reports making a \$250 contribution on 10-5-18. These contributions were not reported by your campaign. If these contributions were received, they must be reported on Schedule A (Contributions and Other Receipts) on the October 29, 2018 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive these contributions, please note this fact in a letter to the Commission.
- 3. Schedule A (Contributions and Other Receipts) and Schedule C (Expenditures and Other Disbursements) of the October 29, 2018 report contain addition errors. The totals listed on both schedules are not the same as the totals on the front page summary sheet. An amended report must be filed correcting these errors.
- 4. The front page summary sheet indicates \$1,000 for Schedule B (In-Kind Contributions) during the October 29, 2018 reporting period. However, no Schedule B was included with the report. A Schedule B must be filed with the in-kind contribution(s) listed for this reporting period.
