Mrs. Renna,

Thank you for the opportunity to respond to your questions on the Notification of Material Error or Omission letters dated July 8, 2019 and June 24, 2020.

I have made the following discoveries regarding the July 8, 2019 inquiry.

1) I improperly reported the 07-12-18 donation from the Kansas Association of Realtors as a donation from Kansas City Regional Assn of Realtors. I have made this change on a revised 12-31-18 Receipts and Expenditures report.

2) I have not yet determined the mistake with the Kansas Auto Dealers Association reports. I can only assume they tracked the donations so they did not have an infraction. I am sure I made a similar error as with the realtor associations, however I have not been able to figure it out. I will write the KS Auto Dealers association a check in the amount of \$200 to correct this error. I will report that transaction under section c (expenditures and Other Disbursements) of my July 27, 2020 report.

In response to the June 24 2020 inquiry, I have made the following changes to my 12-31-19 Receipts and Expenditures report.

1) The donation from QC holdings was written Dec 13, 2018 and was received by me on December 20, 2018. I sent it for deposit on 1/01/19, and inaccurately reported that date as the date in which I received it. I have also made that change to my revised 12-31-2018 report and removed it from my 12-31-2019 report.

2) I have removed all Gas expenditures from my 2019 report and instead have listed a few of my trips to make up for the amounts. I drove many more miles than reported, but only reported enough to make up for the gas expense. I put the details of the trips in the expenditure report.

3) I have added all addresses of all vendors and individuals to the 12-31-2019 report, as requested.

Finally, you had asked for more details about the rental car expense of \$172.40 on 01/11/19, for the week prior to session starting in 2019. I paid for 1 week rental because it was less expensive than renting by day. I was appointed as the Chairman of the Commerce, Labor and Economic Development Committee. In preparation for the



upcoming session, I had to make several trips to Topeka to set up the office and to meet with members. I also drove many miles around Kansas to meet with some of the members of the committee and other interested parties, including all the local chambers of Commerce. Rather than put all these miles on my personal car, I chose to use a rental car. Had I driven my own car, and charged for mileage, it would have been well over \$1000.00. If you would rather I remove the rental and replace it with the mileage, I can certainly do that.

Please feel free to call me with any questions. I have included revised reports for 12-31-2018 and 12'31-2019, and I look forward to correctly reporting on my July 27, 2020 report.

Thanks again for the opportunity to respond. I look forward to putting all this behind us.
