

# Amendment to Ron Ryckman's January 10, 2020 Report

The following explanations are provided below in response to the inquiries submitted by the Kansas Governmental Ethics Commission concerning schedule C of the January 10, 2020 campaign finance report for Rep Ron Ryckman.

1. Schedule C of the January 10, 2020 campaign finance report lists a donation to the Olathe Republican Party in the amount of \$1,000 on 6-24-2019. The campaign was unaware of the party's status as a political action committee and requested a refund of \$1,000 from the Olathe Republican Central Committee political action committee. The Olathe Republican Central Committee refunded the campaign for that donation, and such refund has been received and was successfully refunded on 7/16/20. This refund will be reflected on the campaign finance report due on July 27<sup>th</sup>, 2020.

This expenditure was made inadvertently and Mr. Ron Ryckman refunded the campaign for that expense. The campaign was refunded for that expense on 7/16/20. This refund will be reflected on the campaign finance report due on July 27<sup>th</sup>, 2020.
