1. The beginning balance of \$31,352.12 listed on the January 10, 2021 report is not the same as the ending balance of \$30,368.25 listed on the October 26, 2020 report. This difference of \$983.87 must be explained in an amended report.
2. According to the Candidate Last Minute Contribution Report filed on 10-29-20 by the Cole Fine campaign, the campaign received a \$483.87 contribution on 10-26-20 from Karlie Kloss and a \$500 contribution on 10-27-20 from Eric Schmidt. These contributions were not reported by your campaign on the January 10, 2021 report. These contributions must **also** be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2021 report. These errors will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed.
3. Schedule C (Expenditures and Other Disbursements) lists an expenditure to Cole Fine during the reporting period in the amount of \$1,161.84 for reimbursement. It will be necessary for you to provide a more detailed description of the types of expenses which were reimbursed, i.e., mileage, meals, postage, supplies, reimbursement for radio, newspaper, TV advertising, etc. If any one expense was over \$50 it must be itemized. An amended Schedule C for the January 10, 2021 must be filed disclosing this information.
