- According to the reports filed with the Secretary of State, Interhab Champion Fund reports making a \$250 contribution to Kathy Wolfe Moore on 10-22-20. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2021 report.
- 2. The beginning balance of \$38,654.78 listed on the January 10, 2021 report is not the same as the ending balance of \$31,218.97 listed on the October 26, 2020 report. An amended front page summary sheet must be filed for the January 10, 2021 report with the correct beginning balance.
- 3. According to the Candidate Last Minute Contribution Report filed on 10-28-20 by the Kathy Wolfe Moore campaign, the campaign received seven (7) contributions totaling \$2,750.00 from 10-20-20 through 10-26-20. These contributions were not reported by your campaign on the January 10, 2021 report. These contributions must **also** be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2021 report. These errors will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed.
- 4. Schedule C (Expenditures and Other Disbursements) lists an expenditure to Kathy Moore during the reporting period in the amount of \$832.22 for reimbursement for campaign expenses. It will be necessary for you to provide a more detailed description of the types of expenses which were reimbursed, i.e., mileage, meals, postage, supplies, reimbursement for radio, newspaper, TV advertising, etc. If any one expense was over \$50 it must be itemized. An amended Schedule C for the January 10, 2021 report must be filed disclosing this information.
