- 1. According to the reports filed with the Secretary of State, the Sunflower Seeds PAC reports making a \$500 contribution to Katie For Kansas. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the October 26, 2020 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 2. According to the reports filed with the Secretary of State, the LGBTQ Leadership PAC reports giving a \$300 contribution to Katie for Kansas on 8-25-20. The campaign reports it as \$360. Also, the Johnson County Democratic Women South report giving a \$360 contribution on 8-16-20 and the campaign reports receiving a \$300 contribution. It appears these two contributions are incorrectly reported. Please check your records and amend the report appropriately.
