- 1. The beginning balance of \$12,045.04 listed on the January 10, 2020 report is not the same as the ending balance of \$12,295.04 listed on the **amended** January 10, 2019 report. An amended cover summary page must be filed with the correct beginning balance of \$12,295.04.
- 2. According to the reports filed with the Secretary of State, Enterprise Holdings, Inc. PAC reports making a \$250 contribution to Diana Dierks on 11-7-19. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2020 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 3. Schedule A (Contributions and Other Receipts) of the January 10, 2020 report lists a contribution from HGC (Hein Governmental Consulting) for \$250 on 11-19-19. Please check your records to determine if this contribution was actually from the HCA KS Good Government Fund. They reported giving a \$250 contribution to Diana Dierks on 11-19-19. The Dierks campaign did not report receiving the HCA KS Good Government Fund contribution. An amended Schedule A must be filed with the correct donor for this contribution.
- 4. Schedule C (Expenditures and Other Disbursements) must be amended to include the street or mailing addresses for all individuals and vendors to whom expenditures were made during the January 10, 2020 reporting period.
- 5. Schedule C (Expenditures and Other Disbursements) of the January 10, 2020 report lists 3 expenditures totaling \$1344.90 on 1/3 to Diana Dierks with no purpose of expenditure or disbursement listed for these expenditures. A detailed description for these expenditures must be provided on an amended Schedule C (Expenditures and Other Disbursements). If any one reimbursement was over \$50, it must be itemized.
