- 1. According to the reports filed with the Secretary of State, InterHab Champion Fund reports making a \$250 contribution to Will Carpenter on 10-22-20. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the October 26, 2020 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 2. K.S.A. 25-4153 (a) (1) states, "The aggregate amount contributed to a candidate and such candidate's committee... shall not exceed the following: for member of the house of representatives, . . . \$500 for each primary election... and an equal amount for each general election." The Carpenter campaign reported receiving a \$500 contribution on 8-19-19, and a \$500 contribution on 8-4-20 from the HollyFrontier Corporation PAC for a total of \$1000. Both of these contributions were received during the primary election period.

Pursuant to K.S.A. 25-4153, the campaign accepted a contribution in excess of the legal limit amounting to \$500. We would suggest that this contribution be refunded immediately. The return of this contribution should be noted on Schedule C (Expenditures and Other Disbursements) of the January 10, 2022 Receipts and Expenditures Report.

3. Schedule C (Expenditures and Other Disbursements) of the October 26, 2020 report lists an expenditure to RHCC in the amount of \$2,933.53 on 10-15-20 and another \$2,933.53 on 10-22-20. However, the reports filed by RHCC indicates \$1500 was received on 10-15-20 from the Will Carpenter campaign. Please check your records to determine if these two expenditures totaling \$5,867.06 were made by your campaign to RHCC. If so, please indicate that fact in a letter to the Commission. If not, an amended Schedule C (Expenditures and Other Disbursements) must be filed correcting this discrepancy.
