- 1. According to the reports filed with the Secretary of State, the Republican House Campaign Committee reports receiving one, \$2500 contribution on 10-27-20 from the Brenda Landwehr campaign. However, Schedule C (Expenditures and Other Disbursements) of the January 10, 2021 report lists a \$2500 expenditure to the Republican House Campaign Committee on 10-27-20 and the October 26, 2020 report also lists a \$2500 expenditure on 10-22-20 to the Republican House Campaign Committee. If this \$2500 expenditure is a duplicate entry, the appropriate report must be amended removing the duplicate entry. If the campaign did make two expenditures for \$2500 to the Republican House Campaign Committee, please note this fact in a letter to the Commission.
- 2. Schedule C (Expenditures and Other Disbursements) of the January 10, 2021 report contains numerous expenditures that do not list addresses. An amended Schedule C must be filed which includes the street or mailing addresses for all expenditures in excess of \$50.
- 3. Schedule C (Expenditures and Other Disbursements) of the January 10, 2021 report lists three expenditures to Shaken or Stirred on 10-26-20 in the amount of \$1350 for a benefit at McConnell AFB. An amended Schedule C must be filed providing more explanation for these expenditures.
