- 1. The January 10, 2020 Receipts and Expenditures Report filed by the Rahjes campaign did not reflect the return of an excess contribution from the Farmers Employee & Agent PAC of Kansas. A Notification of Material Error or Omission In A Receipts and Expenditures Report was sent to the candidate & treasurer on June 27, 2019 regarding the \$250 excess contribution. The excess contribution must be refunded immediately. The return of this contribution must be noted on Schedule C (Expenditures and Other Disbursements) of the July 27, 2020 Receipts and Expenditures Report.
- 2. Schedule A (Contributions and Other Receipts) of the January 10, 2020 Receipts and Expenditures Report does not reflect whether the contributions were in the form of cash, check, loan, or Efunds/other. Each entry on Schedule A must be amended to reflect whether the contribution was made by check, cash, was a loan, e-fund or other.
- 3. Schedule C (Expenditures and Other Disbursements) must be amended to include the complete street or mailing addresses for all individuals and vendors to whom expenditures were made during the January 10, 2020 reporting period.
