- 1. The beginning balance of \$2,442.77 listed on the July 27, 2020 report is not the same as the ending balance of \$2,807.59 listed on the January 10, 2020 report. This difference of \$364.82 must be explained in an amended report.
- 2. K.S.A. 25-4153 (a)(1) states, "The aggregate amount contributed to a candidate and such candidate's committee shall not exceed the following: for member of the house of representatives, . . . \$500 for each primary election and an equal amount for each general election." The Phelps campaign reported receiving the following contributions:

All of these contributions were received during the primary election period.

Pursuant to K.S.A. 25-4153, the campaign accepted contributions in excess of the legal limit amounting to \$200. We would suggest that this excess contribution be refunded immediately. The return of the \$200 excess contribution should be noted on Schedule C (Expenditures and Other Disbursements) of the October 26, 2020 Receipts and Expenditures Report.
