

Thank you for the opportunity to respond to your questions on the Notification of Material Error or Omission letter dated September 9, 2022.

I have made the following discoveries regarding the inquiry.

- 1) Kansas Livestock association donated \$250, but I inadvertently typed in \$500. My Bank also found the error because I also made the mistake on my deposit form. I have corrected the amount.
- 2) The Reimbursement from the State of Kansas for franking was deposited into my campaign account, so I have removed the entry from Schedule D to Schedule A, as you suggested.
- 3) The reimbursement from American Legislative Exchange council was also deposited into my campaign account, so I have removed the entry from Schedule D to Schedule A, as you suggested.
