These contributions were not reported by your campaign. If these contributions were received, they must be reported on Schedule A (Contributions and Other Receipts) on the October 31, 2022 report. **If the campaign did not receive these contributions, please note this fact in a letter to the Commission.**

2. Schedule A (Contributions and Other Receipts) of the October 31, 2022 Receipts and Expenditures Reports lists numerous E Fund contributions. The \$1000 loan is not carried forward as a loan payable to the October 31, 2022 report, nor is it disclosed on Schedule C (Expenditures and Other Disbursements). **All loans should be listed on Schedule D (Other Transactions) until such time as they are repaid or forgiven.** An amended October 31, 2022 report must be filed disclosing the disposition of this debt.
