1. The beginning balance of \$106,580.03 listed on the January 10, 2024 report is not the same as the ending balance of \$92,602.88 listed on the amended January 10, 2023 report. It appears that the beginning balance was not changed for the January 10, 2024 report. An amended front page summary sheet must be filed with the correct beginning balance.
2. According to the reports filed with the Secretary of State, the following PAC's report making contributions to the Clayton campaign:

These contributions were not reported by your campaign. If these contributions were received, they must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2024 report. **If the campaign did not receive these contributions, please note this fact in a letter to the Commission.**

3. Schedule C (Expenditures and Other Disbursements) lists an expenditure to Stephanie Clayton on 10-16-23 in the amount of \$1,226.90 for "debt reimbursement". It will be necessary for you to provide a more detailed description of the types of expenses which were reimbursed, i.e., mileage, meals, postage, supplies, reimbursement for radio, newspaper, TV advertising, etc. If any one expense was over \$50 it must be itemized. An amended Schedule C for the January 10, 2024 report must be filed disclosing this information.
4. Schedule C (Expenditures and Other Disbursements) lists a debt reimbursement to Stephanie Clayton on 8-28-23 in the amount of \$504.98. Since the loan payable listed on Schedule D (Other Transactions) in the amount of \$504.98 was reimbursed, it must be removed from Schedule D as an outstanding loan payable.
