Administration of Campaign Finance, Conflict of Interest & Lobbying Laws 1. According to the reports filed with the Secretary of State, the following PAC's report making contributions to the Schmoe campaign:

These contributions were not reported by your campaign. If these contributions were received, they must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2024 report. If the campaign did not receive these contributions, please note this fact in a letter to the Commission.

Schedule B (In-Kind Contributions) of the January 10, 2024 report lists a \$1,000 conference reimbursement from ALEC on 12-15-23 and \$601.46 from NCSL for conference fees on 11-12-23. If these were reimbursements for attending conferences and were deposited into the campaign bank account, they would need to be reported on Schedule A (Contributions and Other Receipts) as reimbursements, not Schedule B (In-Kind Contributions). An amended report must be filed correcting this error.
