1. Schedule D (Other Transactions) of the July 29, 2024 Receipts and Expenditures Report shows an account payable totaling \$166.63 to Superior Rubber Stamp & Seal on 5-3-24 and paid by Jane Byrnes. Schedule C (Expenditures and Other Disbursements) indicates Jane Byrnes was reimbursed on 5-23-24. Since the loan payable was reimbursed during the same reporting period as the loan was initiated, it only needs to be reported on Schedule C, not Schedule D. Only outstanding loans at the end of the reporting period should be listed on Schedule D. An amended Schedule D must be filed removing this loan on Schedule D.
  
2. Schedule B (In-Kind Contributions) lists two in-kind contributions from the candidate for filing fees to the Secretary of State on 5-3-24 for \$120 and again on 6-10-24 for \$120. Schedule D (Other Transactions) of the report indicates the candidate's filing fee was paid on 1-27-24 for \$70 to the Secretary of State. An explanation for these two in-kind contributions must be provided.
