Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. Schedule A (Contributions and Other Receipts) of the July 29, 2024 report lists a \$400 contribution received on 1-2-24 from OneOk Employees PAC and a \$500 contribution being received on 1-4-24 from HCA Kansas Good Government Fund. K.S.A. 25-4153a states that no registered lobbyist, political committee or person, other than an individual, shall make a contribution and no legislator or candidate for the legislature shall accept a contribution from a lobbyist, political committee or person, other than an individual after January 1 and prior to sine die adjournment of the regular session of the legislature or any other time the legislature is in session. These contributions should not have been accepted and should be returned. **The return of these contributions must be shown on Schedule C (Expenditures and Other Disbursements) on the October 28, 2024 report.**
2. Schedule C (Expenditures and Other Disbursements) of the July 29, 2024 report lists an expenditure to Troy Waymaster on 6-15-24 for \$2,037.75 for reimbursement of expenses. It will be necessary for you to provide a more detailed description of the types of expenses which were reimbursed, i.e., mileage, meals, postage, supplies, reimbursement for radio, newspaper, TV advertising, etc. **If any one expense was over \$50 it must be itemized.** An amended Schedule C for the July 29, 2024 report must be filed disclosing this information.
3. The July 29, 2024 report did not disclose a payment to the Secretary of State for the candidate's filing fee that was paid on 4-1-24 in the amount of \$120.00. If the filing fee was paid by the candidate from personal funds, it should be recorded on Schedule B (In-Kind Contributions) as an "in-kind" contribution from the candidate to the campaign. If the filing fee was paid from campaign funds, this expenditure should be listed on Schedule C (Expenditures & Other Disbursements). The July 29, 2024 report must be amended by showing the payment of the filing fee either on Schedule B or Schedule C and on the cover summary page.
