1. On April 17, 2024, a Notification of Material Error or Omission In A Receipts and Expenditures Report was mailed to the Goetz campaign regarding a contribution that was received during session in the amount of \$250 from Black Hills Corporation. The return of this contribution was not reported on Schedule C (Expenditures and Other Disbursements) of the July 29, 2024 report. If it was returned, an amended Schedule C for the July 29, 2024 report must be filed listing the return. If the \$250 contribution has not been returned, it must be done so immediately. The return will be shown on Schedule C of the October 28, 2024 report.
2. The beginning balance of \$7,659.98 listed on the July 29, 2024 report is not the same as the ending balance of \$6,872.54 listed on the amended January 10, 2024 report. An amended July 29, 2024 report must be filed correcting this \$787.44 discrepancy.
3. Schedule C (Expenditures and Other Disbursements) of the July 29, 2024 report lists a \$1000 repayment to Mark Fischer on 2-21-24 for an excess contribution. However, Schedule C of the January 10, 2024 lists a \$1000 reimbursement to Fischer Cattle LLC on 12-30-23. According to the reports filed by the Goetz campaign, only \$1000 has been contributed by Mark Fischer/Fischer Cattle LLC to the campaign. Further explanation or an amended report must be filed explaining the additional \$1000 reimbursement.
