Due to certain data protocols within our PAC accounting software some entries on our January 10, 2006 Receipts and Expenditures Report require clarification. Of particular note is the method by which our software handles "voided" checks, that is checks that were printed and subsequently voided and re-issued without the original check being tendered. Pages 13, 22 and 25 of Schedule A contain voided checks and are listed as contributions under the "Other" column. Each of these entries has a corresponding debit entry in Schedule C (see pages 2, 3 and 5). The effect of these transactions causes the summary totals under Section C lines 2 and 4 to be overstated. Line 5 of the summary is not affected.

Additionally, the report contains refunds from two candidates (Governor Sebelius and Insurance Commissioner Praeger) due to inadvertent contributions exceeding the election cycle limits.
