Dear Ms. Miller,

As a result of numerous changes in Kansas Cable TV PAC bookkeeping staff, we have experienced some discrepancies in our January 10, 2008 Receipts and Expenditures Report. Specifically, the beginning balance does not match the ending balance of the January 10, 2007 Report. Further, the ending balance of the January 10, 2008 Report does not match the beginning balance of the July 28, 2008 Report.

In our review of the filings, we determined that different bookkeeping methods among the various Kansas Cable TV PAC bookkeepers created these inconsistencies. We are confident that there are no financial transgressions, rather simple accounting errors. We are also confident that we have instituted a revised system that will provide the necessary checks and balances to prevent these errors from occurring in the future.

As a result of these recently uncovered discrepancies, we believe the correct beginning and ending balance of the January 10, 2008 Receipts and Expenditures Report should have been \$37,701.17 and \$35,236.88, respectively. These adjustments make this report consistent with the preceding and succeeding reports. Attached is an amended January 10, 2008 Report.


