The Kansas Independent Business Political Action Committee filed the Receipts and Expenditures Report for period ending December 31, 2006, stating ending cash on hand balance of \$2,712.22. Subsequently, the PAC filed the Receipts and Expenditures Report for period January 1, 2007 through December 31, 2007, stating beginning cash on hand of \$2,941.30. These balances should be the same and since they were not, your office sent us a letter dated July 11, 2008, requesting an explanation as to why there was a variance between the two reports.

In 2007, WIBA had a leadership change. The previous WIBA president prepared the 2006 report and the current WIBA president prepared the 2007 report. We believe the \$229.08 variance to be an unintentional clerical error. We have reviewed the 2007 report's beginning balance and compared it with the reconciled bank balance and are confident that \$2,941.30 is the correct beginning cash on hand as of January 1, 2007.
