



I have been out of town for the last several weeks and am just now in receipt of the notification of failure to file the Receipts and Expenditures Report sent to me for the Citizens for Sound Governance PAC. The attorney for the PAC was responsible for insuring the filing of our dissolution and all documents related to that had been forwarded to him with my signature for him to file with your office.
