Dear Mr. Betts,

Enclosed is a letter from Carol Williams, Executive Director of the Governmental Ethics Commission for Kansas.

In the letter, Ms. Williams notes the September 8, 2008 contribution of one thousand dollars (\$1,000.00) from the Kansas 4th District Democratic Party to your campaign for the United States House of Representatives was in violation of K.S.A. 25-4153 (f).

A further review of the campaign reports filed by the Kansas 4th District Democratic Party reveals another contribution by the District Democratic Party to your campaign in the amount of five hundred dollars (\$500.00) on March 6, 2008.

Ms. Williams informs the District Democratic Party that we must obtain an immediate refund of the one thousand dollar contribution, and the five hundred dollar contribution from your campaign fund immediately.

We truly regret the error in making these contributions. We believed we were in compliance with the law. We regret asking you to refund the total amount of the contributions, fifteen hundred dollars, but the law requires us to make this request.

We understand your campaign account may be closed, and any remaining monies distributed to local charities. We are also aware you are now living in Australia.

Please advise us as soon as possible on your plans to return these contributions. You may reach me at the following:

If you are able to make these refunds, it would be helpful to have two separate checks written, one for one thousand dollars, and the other for five hundred dollars as they must be reported on amended reports the 4th District Democratic Committee is obligated to file.


