- 1. The Treasurer for Carpenters Local1445 is indeed Phillip Wike. Joe Brooks is the financial secretary for the Carpenters and also the treasurer for the Local 1445 PAC fund. This error occurred because the document was signed by the wrong treasurer. Joe Brooks will be signing the amended form and the ones hereafter. We are sorry about the inconvience this has caused and will from here on out pay closer attention to signature titles.
- 2. The wrong amount was entered here because it was the amount on the bank statement for 01/02/2010 not the running balance. We had a five hundred dollar check out that had not cleared the bank. Check # 237 has never cleared the bank to date and our account will be credited the \$500 making our actual ending balance for 01/10/09 \$1292.87.
- 3. The addresses were included to all the political offices that we had in our files. We have given you the information that we have and figured that you guys might just have these guys addresses since we have long ago thrown the opened letters with the return addresses away.=(
- 4. The check that we received from the district council of KC was indeed \$14365.38. The difference of 187.05 was our normal 5% deposit for that month.
