
Dear Ms. Williams,

I am writing to you on behalf of the KTLA Civil Justice/Consumer PAC regarding the Receipts and Expenditures report filed in your office for the period covering 1/1/2010 through 7/22/2010.

We have reviewed the report and are writing to offer a clarification. We discovered that we reported on Schedule C: Disbursements and Other Expenditures -\$100.00 to Terrie Huntington dated 1/1/10. Sen. Huntington returned a contribution made to her Senate campaign before 12/31/09 but not deposited in her campaign account before the blackout period. We voided the contribution check she returned. The returned contribution in the amount of \$100.00 should have properly been reported on Schedule A: Contributions and Other Receipts, instead of on Schedule C.
