

We have completed the review of the October 29, 2012 Receipts & Expenditures Report that you filed for the Kansans for Limited Government PAC.

During the review, we found a contribution in excess of \$300 that was received by the PAC. This contribution of \$10,000.00 from Petroleum Inc should have been shown on the Last Minute Contributions Report and filed with the Secretary of State on August 3, 2012. You were mailed the appropriate form, along with a cover letter explaining the requirement.

In the future, you must be certain that any last minute contribution in excess of \$300 is reported on the appropriate date. The failure to do so may result in a civil fine being assessed by the Governmental Ethics Commission.
