- 1.The October 31, 2016 Receipts and Expenditures Report filed by John Carmichael shows a \$200 contribution on 8/3/2016 from the Kansas' Wine & Spirits Wholesalers PAC. This expenditure was not reported by your committee. If this expenditure was made, it must be reported on Schedule C (Total Expenditures and Other Disbursements) of the October 31, 2016 report. This error will cause the cash balance on the front-page summary sheet to be incorrect. Therefore, an amended front-page summary sheet must also be filed. If your committee did not make this expenditure, please note this fact in a letter to the Commission.
- 2. The contribution check to Chuck Smith in the amount of \$200 on 8/30/2016 was never received by his campaign. An amended Schedule C (Total Expenditures and Other Disbursements) must be filed with the expenditure removed to balance the committee's report. This error will cause the cash balance on the front-page summary sheet to be incorrect. Therefore, an amended front-page summary sheet must also be filed.
- 3. The October 31, 2016 Receipts and Expenditures Report filed by the Kansas' Wine & Spirits Wholesalers PAC reports a \$200 expenditure on 10/24/2016 made to Clay Aurand. The actual amount of the contribution check was \$150. An amended Schedule C (Total Expenditures and Other Disbursements) must be filed reporting the corrected amount. This error will cause the cash balance on the front-page summary sheet to be incorrect. Therefore, an amended front-page summary sheet must also be filed
- 4. In addition to filing the amended report for October 31, 2016, the front-page summary sheet for the January 10, 2017 report will have to be amended for it to reflect the corrected amount of the amended ending balance of the October report.
