The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. The beginning balance of \$4,459.56 listed on the report filed on October 31, 2016 for the Kansas Beer Wholesalers Association PAC is not the same as the ending balance of \$3,055.20 listed on July 25, 2016 report. This difference of \$1404.36 must be explained in an amended report.

2. In addition to filing the amended report for October 31, 2016, the front page summary sheet for the January 10, 2017 report will have to be amended in order for it to reflect the corrected amounts of the amended ending balance of the October report.

3. According to the last minute contributions and independent expenditures report filed by the Kansas Beer Wholesalers Association PAC on July 28, 2016, the PAC received a \$6052.85 contribution on 7-26-16 from House of Schwan. The PAC made an expenditure of \$500 to Jeremy Alessi for House on 7-26-16, and a \$1,000 expenditure to Mike Petersen for Senate on 7-26-16, and an expenditure of \$3,148.49 to Total Printing Solutions on 7-26-16. These contributions and expenditures were not reported by your PAC on the October 31, 2016 report. These contributions and expenditures must **also** be reported on Schedule A (Contributions and Other Receipts) and Schedule C (Expenditures and Other Disbursements) on the October 31, 2016 report. These errors will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed.
