- 1. The beginning balance of \$3,797.81 listed on the report filed on January 8, 2016 is not the same as the ending balance of \$3,622.81 listed on January 10, 2015 report. This difference of \$175 must be explained in an amended report.
- 2. Schedule A (Contributions and Other Receipts) must be amended to include the street or mailing addresses for all individuals who contribute more than \$50 to the committee during the reporting period. In addition, further explanation must be given for these contributions:

- 3. Schedule C (Expenditures and Other Disbursements) must be amended to include the street or mailing addresses for all expenditures over \$50 that were made during the reporting period.
- 4. The contribution checks to Ty Masterson in the amount of \$200 and Mike Petersen in the amount of \$200 on 9/30/2014 were never cashed. These two checks must be shown as Other Receipts on Schedule A (Contributions and Other Receipts) to balance the committee's report.

If the committee has a new Treasurer, a new Statement of Organization must be filed. Enclosed is a Statement of Organization form for your use.
