- 1. Schedule C (Expenditures and Other Disbursements) must be amended to include the street or mailing addresses for all individuals and vendors to whom expenditures in excess of \$50 were made during the reporting period.
- 2. The October 29, 2018 Receipts and Expenditures Report filed by candidate Tom Sawyer shows the Builders Association of Kansas PAC making a \$200 contribution on 10/15/18. This contribution was not reported by your Committee. If this contribution was given, it must be reported on Schedule C (Expenditures and Other Disbursements) of the October 29, 2018 report.
- 3. The October 29, 2018 Receipts and Expenditures Report filed by candidate Jason Probst shows the Builders Association of Kansas PAC making one (1) \$200 contribution on 10/23/18. However, your Committee reported giving two (2) contributions of \$200 to Jason Probst on 10/23/18. If this is a duplicate entry, Schedule C (Expenditures and Other Disbursements) of the October 29, 2018 report must be amended to fix the error.

These errors will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If your committee did not give these contributions, please note this fact in a letter to the Commission.
