On December 14, 2017 Jeff Colyer reported receiving a \$500 contribution to the Kansas Health Care Association PAC, however, your committee only reports it as a \$250 contribution in Schedule C (Expenditures and Other Disbursements) of the January 10, 2018 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed.
