- Bank statements match reports up to October 25, 2018
- Typo on October 29, 2018 report
 - Says that cash balance on Oct 25 2018 was \$1,056.67 when it was actually \$1,086.67, and indeed the items on the report add to the correct amount in the bank account. This is a typo of -\$30 (reporting that cash on hand is \$30 less than it actually is)

- January 10th, 2019 report
 - Starting balance is incorrect, says \$1,056.67 when it should be \$1,086.67
 - Missing two deposits of \$400 on 12/19/2018 and \$100 on 12/20/2018, meaning total cash received should be \$600, and line 3 should be \$1,686.67
 - Expenditures are correct, \$1,154.95
 - Total cash on hand on December 31, 2018 should be \$531.72, which matches bank statement

- January 10th, 2020 report
 - Starting balance is incorrect, says \$1.72 when it should be \$531.72
 - Contributions
 - In general, it appears many contributions are entered identically twice
 - January 2019: report has funds of \$4.17, \$4.17, \$25, \$5, \$25, \$5, \$10, that are not in bank statement. Bank has deposit of \$1,000 that is not in report.
 - January total contributions: \$148.34 on report, statement shows \$1,070
 - February 2019: report has funds of \$25, \$5, \$100, \$50 that are not in bank statement.
 - February total contributions: \$360 on report, statement shows \$180
 - March 2019: report has funds of \$25, \$5, \$1,000 that are not in bank statement. Bank statement has deposit of \$125 not in report
 - March total contributions: \$2,060 on report, statement shows \$1,155
 - April 2019: report has funds of \$25, \$5, \$25 that are not in bank statement
 - April total contributions: \$110 on report, statement shows \$55
 - May 2019: report has various doubled funds. Fund reporting is correct, but all are doubled
 - May total contributions: \$910 on report, statement shows \$455
 - June 2019: report has various doubled funds. Fund reporting is correct, but all are doubled

 - E Funds from Mike Bruner were made on 10/24 but did not hit bank until 10/28, so that \$50 doesn't belong on this report

 - Reports have gotten significantly more accurate as time has gone on
 - Many problems are due to the fact that previous treasurers were looking at Actblue contribution dates rather than when the money actually hit the bank
 - For a period of time years ago, KYD did not have a treasurer, making quite a mess for the previous treasurer to fix
 - Some of the errors cancel out, meaning that the report balance and actual balance are not actually that different right now
 - Current difference is \$59.06

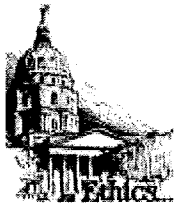
