NOTIFICATION OF FAILURE TO FILE THE OCTOBER 26, 2020 RECEIPTS AND EXPENDITURES REPORT

In checking with the Secretary of State, we have been informed that you have failed to file an **October 26, 2020 Receipts and Expenditures Report** as required by K.S.A 25-4148. The Report must be completed and filed within five (5) days from the date of this notice.

As provided by K.S.A. 25-4152:

- If your committee has received or anticipates receiving contributions of \$2,501 or more in the 2020 calendar year, you have until **October 29, 2020**, which is 2 days from the date of this notice, to comply with the reporting requirements before a civil penalty is imposed - \$100 for the first day and \$50 per day thereafter for each day the required report remains unfiled. No civil penalty shall exceed one thousand dollars (\$1,000).
- If your committee has received or anticipates receiving contributions of \$2,500 or less in the 2020 calendar year, you have until **November 11, 2020**, which is 15 days from the date of this notice, to comply with the reporting requirements before a civil penalty is imposed - \$10 per day the required report remains unfiled. No civil penalty shall exceed three hundred dollars (\$300).

File the required Report within five (5) days with the Secretary of State. As provided by law, a copy of this notice has been made a part of your record in the Secretary of State's office.

**NOTIFICATION OF FAILURE TO FILE A PAC REGISTRATION FOR THE
YEAR 2020**

In checking with the Secretary of State, we have been informed that you have failed to file a **2020 Registration Statement and accompanying fee** as required by K.S.A. 25-4145. The Statement and fee must be completed and filed within five (5) days from the date of this notice.

As provided by K.S.A. 25-4152, you have until **November 11, 2020**, which is 15 days from the date of this notice, to comply with the reporting requirements before a civil penalty is imposed - \$10 per day the required document remains unfiled. No civil penalty shall exceed three hundred dollars (\$300). Also, there are criminal penalties for intentionally failing to file. The intentional failure to file the required Statement and fee within five (5) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures until the required Statement and fee has been filed.

File the required Statement and fee within five (5) days with the Secretary of State. As provided by law, a copy of this notice has been made a part of your record in the Secretary of State's office.
