

I left you a message earlier in the week regarding your letter dated July 22, 2020. The contribution from the Kansas City Regional Assn of Realtors PAC was correctly reported by you. The Kansas City Regional Assn of Realtors PAC reported giving you 3 contributions during the 2018 primary election cycle. \$150 on 7-21-17, \$150 on 12-31-17 and \$500 on 7-12-18 for a total of \$800 as indicated on the Notification of Material Error or Omission In A Receipts and Expenditures Report dated July 8, 2019. That is an excess contribution of \$300. The Kansas Realtors PAC did give you a \$500 contribution on 6-27-18 which you correctly reported on July 30, 2018 report as a primary election cycle contribution as well.

You stated in your letter that you made this change on a revised 12-31-18 Receipts and Expenditures Report. I do not receive a copy of the revised report. If you have not made the correction, I wanted to let you know that it is not necessary. However, the excess \$300 must be returned to the Kansas City Regional Assn of Realtors PAC immediately and noted on the October 26, 2020 Receipts and Expenditures Report.
