After discussion with our Vendor, we discovered the contribution was received and deposited. We have issued a refund of these funds, and the contribution has been attributed to the Non-Federal account as of December 4th.
- 2. The Kansas Democratic Party received a \$3000 contribution from Tony Brown on 11/5/2008. This was a personal contribution, and should not have been attributed to his campaign. It has been amended on our report.
- 3. The Kansas Democratic Party did not make a contribution to the Rebecca Escalante campaign. A \$500 contribution was made from the First Legislative Victory Fund on 10/20/2008 to her campaign.
