


I am writing to advise you that I made some errors on my July 28, 2008 Receipts And Expenditures Report Of A Candidate For A State Office which I filed with the Secretary of State and the Labette County Clerk.

The errors are minor but they will involve filling amended reports for both July 28 and October 27, 2008.

On Saturday July 19, 2008 while attending a campaign event in Mound Valley I accepted \$70.00 in cash contributions which I reported. The error I committed was I used the cash to purchase fuel in Altamont on that day and for parking and food purchases at the Cherokee County Fair in Columbus. These expenditures were reported in the original report filled in July. Since the expenditures were for travel and meal expenses by a candidate and a candidates spouse and are therefore exempt from the reporting requirements they will be removed from the amended report. I have reimbursed my campaign with a personal check (a photocopy is attached for verification).

The other error was in reporting expenditures made after July 24, 2008 on the July 28, 2008 report. This error shows less cash on hand than actually existed for the report time.
