

Per the conversation the recent conversation with your office earlier this month, this letter is to correct and clarify the two issues raised on the June 5, 2009, "Notification of Material Error or Omission In a Receipts and Expenditures Report."

Issue 1:

The contribution reported as omitted was actually reported on the October 27, 2008, Ethics report on the last line of page 12, "Schedule A Contributions and Other Receipts":

Issue 2:


