Dear Ms Williams:


My name is Uzo Ohaebosim and I represent Mr. Kelechi Ohaebosim, 2008 candidate for state senator in the 29<sup>th</sup> district in Wichita. I also acted as fundraising chair during his campaign. We are in receipt of your June 5 letter to Kelechi Ohaebosim. In it the issue revolves around an in-kind contribution in excess of the legal limit in the amount of \$747.07 made by Dr. Linus Ohaebosim. Mr. Ohaebosim's campaign did report an in-kind contribution for \$500 on 5-25-08, \$430 on 6-17-08, \$700 on 7-26-08 and an additional \$117.07 on 7-28-08 for a total of \$1747.07.

The excess amount of \$747.07 should not have been attributed to Dr. Linus Ohaebosim. As you know, the aggregate amount contributed to a candidate for the office of state senator shall not exceed \$1000 for the primary election and an equal amount for the general election. Businesses/corporations are bound by the same rules, but a business entity is separate from an individual owner for purposes of campaign contributions. Dr. Linus Ohaebosim contributed \$500 on 5-25-08 and \$430 on 6-17-08. Ohaebosim Medical Clinic, Inc contributed \$700 on 7-26-08 and an additional \$117.07 on 7-28-08. If aggregated the total amount contributed equals \$1747.07. What should have been recorded was \$930 being attributed to Dr. Linus Ohaebosim and \$817.07 being attributed to Ohaebosim Medical Clinic, Inc. With the \$817.07 being properly attributed to Ohaebosim Medical Clinic, Inc, Dr. Linus Ohaebosim did not make a contribution in excess of the \$1000 that election rules state a candidate for state senator can receive from an individual donor during a primary.
