Dear Governmental Ethics Commission;

This letter is in response to your letter of June 4, 2009 regarding the Receipts and Expenditures Report of October 27, 2008 for Senator Janis Lee.

In your notification of Material Error or Omission Report two contributions were cited as making the aggregate amount from those two contributors to amount to over \$1,000 in the primary election cycle.

In both cases the checks were dated during the primary cycle but were not received by the Janis Lee campaign until after August 5, 2008 (the date of the primary). I am enclosing documentation to show that in both cases the letters presenting the checks were dated after August 5, 2008.

In the case of Anheuser Busch Companies, the 4th check you have listed was dated June 26, 2008 but the letter presenting the check is dated August 7, 2008.

In the case of DCP Midstream LP the check dated Aug. 5, 2008 was presented to me in a letter dated Aug. 8, 2008.

I have enclosed copies of both letters with the checks in question. As a result of this information I do not believe that I need to return these two contributions.
