The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. Schedule D (Other Transactions) of the July 30, 2012 report indicates \$401.92 for out-of-pocket expenditures the candidate made to the campaign during this reporting period. Any expenditures made from personal funds which are not deposited into a campaign bank account, and not reimbursed during the same reporting period, are to be listed on Schedule B as in-kind contributions from the donor with a description of the in-kind contributions, i.e., campaign supplies, newspaper ads, yard signs, etc., as well as listed on Schedule D for future reimbursement. An amended Schedule B (In-Kind Contributions) must be filed itemizing the in-kind contributions from Schedule D.

2. Schedule C (Expenditures and Other Disbursements) of the July 30, 2012 report indicates an expenditure to the Kansas Democratic Party in the amount of \$520 for Washington Days. The Kansas Democratic Party reports receiving \$320 from the Haley for Kansas campaign during this reporting period. Please check your records to determine the correct amount of the contribution. If the contribution was \$320, an amended Schedule C must be filed with the correct amount.

3. Schedule A (Contributions and Other Receipts) indicates your campaign accepted the following cash contribution over \$100:

K.S.A. 25-4153(i) states, "No person shall make any contribution or contributions to any candidate or the candidate committee of any candidate in the form of money or currency of the United States which in the aggregate exceeds \$100 for any one primary or general election, and no candidate or candidate committee of any candidate shall accept any contribution or contributions in the form of money or currency of the United States which in the aggregate exceeds \$100 from any one person for any one primary or general election."

The cash contribution listed above should not have been accepted by the campaign. In the future, you must be certain that all contributions in excess of \$100 are made by check, cashier's check or money order.
