

As provided by law, a copy of this notice has been made a part of your record in the Secretary of State's Office. The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures following the end of the thirty (30) day period if the amended report has not been filed.

Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. According to the reports filed with the Secretary of State, Kansas Wine & Spirits Wholesalers PAC reports making a \$1000 contribution to Anthony Hensley on 8-28-12. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the October 29, 2012 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.

2. Schedule D (Other Transactions) of the October 29, 2012 Receipts and Expenditures Report shows a \$10,000.00 loan from the candidate on 9-26-12. All loans should also be listed on Schedule A (Contributions and Other Receipts). An amended report must be filed which includes this loan on Schedule A and the corresponding entry on Line 2 of the cover summary page.

3. According to the Candidate Last Minute Contribution Report filed on 7-31-12 by the Anthony Hensley campaign, the campaign received a \$1000 contribution on 7-31-12 from Chesapeake Operating, Inc. This contribution was not reported by your campaign on the October 29, 2012 report. This contribution must **also** be reported on Schedule A (Contributions and Other Receipts) on the October 29, 2012 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed.

4. K.S.A. 25-4148 (b) (7) requires that when an expenditure is made by payment to an advertising agency, public relations firm or political consultants for disbursement to vendors, the report of such expenditure shall show in detail the name of each such vendor and the amount, date and purpose of the payment to each. Expenditures totaling \$58,000.00 were made to LUC Media for TV buys. Please submit the required supplemental information as an amendment to Schedule C on the October 29, 2012 Receipts and Expenditures Report.
