As provided by law, a copy of this notice has been made a part of your record in the Secretary of State's Office. The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures following the end of the thirty (30) day period if the amended report has not been filed.

Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

K.S.A. 25-4153 (a) (1) states, "The aggregate amount contributed to a candidate and such candidate's committee . . . shall not exceed the following: for the office of state senator, . . . \$1000 for each primary election . . . and an equal amount for each general election." The Teichman campaign reported receiving a \$250 contribution on 12-27-11 from the Kansas Health Care Association PAC, and \$1000 on 7-23-12, for a total of \$1250. Both of these contributions were received during the primary election period.

Pursuant to K.S.A. 25-4153, the campaign accepted a contribution in excess of the legal limit amounting to \$250. We would suggest that this contribution be refunded immediately. The return of this contribution should be noted on Schedule C (Expenditures and Other Disbursements) of the October 29, 2012 Receipts and Expenditures Report.

- 2. Schedule D (Other Transactions) of the July 30, 2012 report lists two excess contributions that were returned on 7-13-12. These refunds totaling \$350 must be itemized on Schedule C (Expenditures and Other Disbursements). An amended July 30, 2012 report must be filed listing the refunds on Schedule C and removing the refunds from Schedule D. Lines 4 and 5 on the cover summary page reflect the \$350 refunds, however, line 7 should be 0. An amended cover summary page must be filed with the correct total on line 7.
- 3. The July 30, 2012 report did not disclose a payment to the Secretary of State for the candidate's filing fee. If the filing fee was paid by the candidate from personal funds, it should be recorded on Schedule B (In-Kind Contributions) as an "in-kind" contribution from the candidate to the campaign. If the filing fee was paid from campaign funds, this expenditure should be listed on Schedule C (Expenditures & Other Disbursements). The July 30, 2012 report must be amended by showing the payment of the filing fee either on Schedule B or Schedule C and on the cover summary page.
