Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. K.S.A. 25-4153 (a)(1) states, "The aggregate amount contributed to a candidate and such candidate's committee . . . shall not exceed the following: for the office of state senator, . . \$1000 for each primary election . . . and an equal amount for each general election." The Bollier campaign reported receiving a \$1000 contribution on 6-25-16 from Steven Simpson, and an additional \$1000 on 7-24-16, for a total of \$2000. Both of these contributions were received during the primary election period.

Pursuant to K.S.A. 25-4153, the campaign accepted a contribution in excess of the legal limit amounting to \$1000. We would suggest that this contribution be refunded immediately. The return of this contribution should be noted on Schedule C (Expenditures and Other Disbursements) of the January 10, 2018 Receipts and Expenditures Report.

2. According to the reports filed by the Kansas Pharmacists Association PAC, they report giving one \$500 contribution during the primary election period on 6-6-16 to the Bollier campaign. However, the campaign reported receiving a \$500 contribution on 6-6-16 and again on 7-25-16. Please check your records to determine the contributor of the \$500 contribution that was received on 7-25-16.
