According to the reports filed with the Secretary of State, AT & T PAC reports making a \$500 contribution on 12-29-14 and Kansas American Family Insurance PAC reports making a \$250 contribution on 9-9-14. These contributions are not reported by your campaign. If these contributions were received, they must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2015 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive these contributions, please note this fact in a letter to the Commission.
- 2. K.A.R. 19-29-5(6) states computer generated campaign reports will be acceptable provided that the type is no smaller than pica (10 characters per inch). K.S.A. 25-4148(e) further states that the Commission may require any treasurer to file an amended report for any period for which the original report filed by such treasurer contains material errors or omissions.

The font size for the January 10, 2015 Receipts & Expenditures Report filed by the Julia Lynn for Senate campaign is too small. An amended report must be filed with a font size of 10 or larger.
