- 1. According to the reports filed with the Secretary of State, the Kansas Credit Union PAC reports making a \$250 contribution to Jeff King on 10-29-13. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2014 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 2. Schedule A (Contributions and Other Receipts) of the January 10, 2014 report lists a \$250 contribution being received on 9-4-13 from Southern Star Central Gas Pipeline. K.S.A. 25-4153a states that no registered lobbyist, political committee or person, other than an individual, shall make a contribution and no legislator or candidate for the legislature shall accept a contribution from a lobbyist, political committee or person, other than an individual after January 1 and prior to sine die adjournment of the regular session of the legislature or any other time the legislature is in session. The legislature held a special session September 3 and 4, 2013. This contribution should not have been accepted and should be returned. The return of this contribution must be shown on Schedule C (Expenditures and Other Disbursements) of the January 10, 2015 report.
