- 1. Schedule D (Other Transactions) of the July 25, 2016 report shows a \$122.13 loan payable to Anabel Larumbe on 6-8-16. All loans should be listed on Schedule A (Contributions and Other Receipts) if the contribution(s) were deposited into the campaign bank account. If the expenses were paid for from personal funds, and not paid from the campaign account they should be itemized on Schedule B (In-Kind Contributions) as "in-kind" contributions from the candidate to the campaign. An amended report must be filed which includes these loans on Schedule A and/or Schedule B and a cover summary page with the correct totals.
- 2. The July 25, 2016 report did not disclose a payment to the Secretary of State for the candidate's filing fee. If the filing fee was paid by the candidate from personal funds, it should be recorded on Schedule B (In-Kind Contributions) as an "in-kind" contribution from the candidate to the campaign. If the filing fee was paid from campaign funds, this expenditure should be listed on Schedule C (Expenditures & Other Disbursements). The July 25, 2016 report must be amended by showing the payment of the filing fee either on Schedule B or Schedule C and on the cover summary page.
