These errors cause the campaign account to have a negative ending balance of \$11.00. An amended cover summary page must be filed with the correct totals.
- 2. Schedule D (Other Transactions) of the October 31, 2016 Receipts and Expenditures Report lists an account payable totaling \$1120 to Arrowhead Outdoor, LLC. Schedule C (Expenditures and Other Disbursements) of the January 10, 2017 report lists a \$500 payment to Arrowhead Outdoor on 11-4-16, leaving an account payable balance of \$620. This payable balance is not carried forward as an account payable to the January 10, 2017 Receipts and Expenditures Report. All account payables must be listed on Schedule D (Other Transactions) until such time as they are repaid. An amended January 10, 2017 report must be filed disclosing the disposition of this debt.
