I have had the opportunity to evaluate the Campaign Finance Receipts & Expenditures Reports for 2016, 2017, 2018, 2019 and 2020 to assist you in identifying the variance noted between the ending cash on the 2019 report and the beginning cash on the 2020 report.

Cash on Hand -12/31/19 (Per 2019 Report)	\$ 33,066.40
Unidentified Variance	(2,102.64)
Cash on Hand -12/31/19 (Per 2020 Report)	<u>\$ 30,963.76</u>

The primary cause of the difference is that the ending cash on hand per the 2019 report was the sum of the aggregate activity of all previous reports, while the beginning cash on hand per the 2020 report was simply the "per bank" balance at December 31, 2019. There appears to have been several items incorrectly reported in 2016 through 2019, in addition to several outstanding checks at December 31, 2019 that were not considered when the 2020 reports were prepared. These factors are summarized as follows:

- For 2016, there were multiple reports filed for interim periods. Per review of these 2016 reports, I was able to identify an aggregate variance of \$2,449.33. I also noted that one of the interim period reports for 2016 appears to have been inadvertently identified as being for the period of 2015. The 2016 differences can be summarized as follows:
  - There were \$2,698.85 of various expenses that appear to have been omitted from the reports
  - There was a \$2.02 immaterial difference in aggregate expenses that were individually <\$50
  - One reported expenditure of \$97.50 never did clear the bank
  - There appears to have been individual receipts of <\$50 that aggregated \$150 that were not included on the report
- On the 2017 report, there is a difference of \$2,449.33 that existed at December 31, 2016. I have not had access to your 2015 and 2016 bank statement to identify this error
- On the 2017 report, there was one disbursement duplicated on the report and two small expenditures inadvertently omitted from the report resulting in a net difference of \$222.38
- On the 2018 report, there was an expenditure reported that never cleared the bank, and a couple of expenditures inadvertently omitted from the report resulting in a net difference of \$<133.69>
- On the 2020 report, there were three outstanding checks at December 31, 2019 of \$258 not deducted from the beginning cash balance

The differences are summarized in greater detail as follows:


