- 1. Schedule D (Other Transactions) of the July 27, 2020 Receipts and Expenditures Report lists loans payable totaling \$1,582.19 to Kirk Miller. These loans are not listed on Schedule D of the October 26, 2020 report, nor are they disclosed on Schedule C (Expenditures and Other Disbursements). All loans should be listed on Schedule D (Other Transactions) until such time as they are repaid or forgiven. An amended October 26, 2020 report must be filed disclosing the disposition of these debts.
- 2. According to the reports filed with the Secretary of State, the Nemaha County Democratic Party reports giving Kirk Miller a \$100 contribution on 9-2-20 and another \$100 contribution on 10-12-20. The Kirk Miller campaign reports receiving a \$100 contribution on 9-8-20 and a \$250 contribution on 10-16-20. There is a \$150 discrepancy in the amount reported for the contribution given on 10-12-20. Please check your records to determine the amount of this contribution. If the contribution was \$100 as reported by the party, an amended Schedule A (Contributions and Other Receipts) must be filed with the correct amount. If the amount is correct, no amendment is necessary.
