1. According to the reports filed with the Secretary of State, the Kansas Automobile Dealers Election Action Committee reports making a \$500 contribution to the Holland campaign on 9-22-20. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the October 26, 2020 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. **If the campaign did not receive this contribution, please note this fact in a letter to the Commission.**

2. Schedule A (Contributions and Other Receipts) of the October 26, 2020 report lists a \$300 contribution from the Kansans For Quality Mental Health on 9-13-20. This contribution is not reported by the PAC. Please check your records to determine if this \$300 contribution was from the Kansans For Quality Mental Health. If not, an amended Schedule A must be filed with the correct donor. If the campaign reported the contribution correctly, no amendment is required.
